In conformity with V.A. Gen. Stat. 631-330.54, the aforementioned rate also applies after judgment.
- The undersigned acknowledges that Capps Home Building Center Inc may change the terms and conditions set forth herein by sending written notification to the undersigned, at the address referenced herein, and that the changes will be part of the Agreement unless the undersigned notifies Capps Home Building Center in writing of any objections to said changes within 10 days of the mailing. Capps Home Building Center reserves the right to revoke the extension of credit to applicant at any time.
- Purchases and/or deliveries are herewith authorized to be made without signature. Buyer shall have an agent on the job site to sign for all
  materials. In case of absence, seller may, at its option, deliver the same. It is agreed that all invoices and delivery tickets, whether signed or not
  shall be deemed true and accurate unless alleged discrepancies are reported in writing to Capps Home Building Center Inc, 13700 Booker T.
  Washington Hwy, Moneta, VA 24121 within 10 days of statement due date.
- Credit applicant agrees that all sales and deliveries as to any individual are, for mechanic's lien purposes, all deemed to be part of a single contract to supply all requested materials for said lot. Each delivery and invoice on each lot is not to be deemed a separate contract for purpose of complying with the Virginia mechanic's lien statues. The purpose of this agreement and understanding is to avoid the necessity of Capps Home Building Center having to file multiple mechanics' liens in the future in the event each invoice was deemed to be a separate contract.
